New York City Bar Association Rates Candidates for Civil Court, District Attorney, Kings County Surrogate's Court and Supreme Court

New York, October 16, 2023 - The New York City Bar Association has completed evaluations of the following candidates who are running in general elections on November 7 for District Attorney, Surrogate's Court, Civil Court and Supreme Court. The review was conducted by the Association's Committee on the Judiciary.

The Committee uses two ratings: <u>Approved</u> and <u>Not Approved</u>. Candidates rated <u>Approved</u> have affirmatively demonstrated qualifications necessary for the performance of the duties of the position for which they are being considered.

In June, the City Bar rated candidates who were running in contested primary elections for Civil Court and District Attorney, and those evaluations are <u>here</u>.
